## 1.0 Introduction

This program directory is intended for the system programmer responsible for program installation and maintenance. It contains information concerning the material and procedures associated with the installation of Network Control Program. This publication refers to Network Control Program as NCP V7R8.1 MVS. You should read all of this program directory before installing the program and then keep it for future reference.

The program directory contains the following sections:

- 2.0, "Program Materials" on page 4 identifies the basic and optional program materials and documentation for NCP V7R8.1 MVS.
- 3.0, "Program Support" on page 9 describes the IBM support available for NCP V7R8.1 MVS.
- 4.0, "Program and Service Level Information" on page 10 lists the APARs (program level) and PTFs (service level) incorporated into NCP V7R8.1 MVS.
- 5.0, "Installation Requirements and Considerations" on page 11 identifies the resources and considerations for installing and using NCP V7R8.1 MVS.
- 6.0, "Installation Instructions" on page 30 provides detailed installation instructions for NCP V7R8.1 MVS. It also describes the procedures for activating the functions of NCP V7R8.1 MVS, or refers to appropriate publications.

Before installing NCP V7R8.1 MVS, read 3.2, "Preventive Service Planning" on page 9. This section tells you how to find any updates to the information and procedures in this program directory.

Do not use this program directory if you are installing NCP V7R8.1 MVS with a SystemPac or ServerPac. When using these offerings, use the jobs and documentation supplied with the offering. This documentation may point you to specific sections of the program directory as required.

If you are installing NCP V7R8.1 MVS using the MVS Custom-Built Product Delivery Offering (CBPDO, 5751-CS3), a softcopy program directory is provided on the CBPDO tape which is identical to the printed copy shipped with your order. Your CBPDO contains a softcopy preventive service planning (PSP) upgrade for this product. All service and HOLDDATA for NCP V7R8.1 MVS are included on the CBPDO tape.

The 3746 Model 900 CSS feature is a licensed offering that allows the operation of an IBM 3746 Model 900 attached to a 3745 Communication Controller. Prior to NCP V7R6, you were required to license, order, and install separate software media. Starting with NCP V7R6 the media containing the 3746 Model 900 CSS feature code has been incorporated into the base code of NCP. You are no longer required to install separate 3746 Model 900 CSS software media when attaching the IBM 3746 Model 900 to a 3745 Communication Controller. Please note that you **must** still obtain a license for the 3746 Model 900 CSS feature. Refer to the NCP V7R6 announcement letter (297-342) dated September 9, 1997 for additional licensing instructions.

Airline Control Interconnect (ALCI) RPQ is a free feature offered in NCP V7R8.1. Previously, you were required to license, order, and install the ALCI RPQ as a separate feature. Starting with NCP V7R6, the ALCI RPQ has been incorporated into the NCP base product tape. You are no longer required to order and install separate media for ALCI. You must continue to license the ALCI feature as in previous releases. Refer to the NCP V7R8 announcement letter (299-223) dated August 17, 1999 for additional hardware requirements information.

Starting with EP R14, users of EP Standalone must install NCP. Users of PEP and EP Standalone will now install EP in the NCP distribution libraries, ANCPMAC1 and ANCPMOD1, using the NCP target and distribution zones. A single EP installation can now be used in environments requiring both PEP and EP Standalone.

IBM recommends that you use an OS/390 ServerPac to install this level of NCP. If you use a ServerPac, you get the service integrated in the product. ServerPac is available at no additional charge when you have an OS/390 license.

A good place to start any task regarding this program is *NCP V7R8, SSP V4R8, and EP Release 14 Library Directory* (SC30-4025). This directory gives you an overview of NCP, SSP, and EP and directs you to a variety of tasks related to these programs.

## 1.1 NCP V7R8.1 MVS Description

NCP V7R8.1 MVS executes in the IBM 3745 Communication Controller for which it has been generated and into which it has been loaded.

NCP V7R8.1 MVS performs a wide range of functions for the data communication network, such as transmission control, communication control, error recording and recovery, and diagnosis.

### 1.1.1 Transmission Control

Standard functions of the network control program include: recognizing and reacting appropriately to control characters, controlling communication line time-outs, checking for errors. It also includes assembling serial bit-streams, received from a data link, into characters in a buffer.

### 1.1.2 Communication Control

The network control program takes over most of the control of the links from the communication access method, performing such functions as data link activation and deactivation, control character insertion and deletion, dynamic buffering, and communication line speed selection.

### **1.1.3 Error Recording/Recovery and Diagnostics**

The network control program maintains several types of error records and provides diagnostic capabilities. These include permanent line error recording, statistics recording, dynamic display of controller storage, and online testing. This support is provided in combination with the IBM 3745 maintenance and operator subsystem (MOSS) and the appropriate operator console.

### **1.1.4 Emulation Mode Support**

When executing in a channel-attached communication controller, NCP V7R8.1 MVS can operate data links in emulation mode as well as network control mode, through the partitioned emulation programming (PEP) extension to NCP V7R8.1 MVS. The PEP extension allows the communication controller to emulate most operations of an IBM 2701 Data Adapter Unit or an IBM 2702 or 2703 Transmission Control Unit (or any combination of the three) for certain data links, while performing network control functions for other links. For the IBM 3745, the facilities offered by MOSS and the appropriate operator console are available to the user of emulation mode support.

## **1.2 NCP V7R8.1 MVS FMIDs**

NCP V7R8.1 MVS consists of FMID HNC7812.

---

## 2.0 Program Materials

An IBM program is identified by a program number and a feature number. The program number for NCP V7R8.1 MVS is 5648-063.

Basic Machine-Readable Materials are materials that are supplied under the base license and feature code, and are required for the use of the product. Optional Machine-Readable Materials are orderable under separate feature codes, and are not required for the product to function.

The program announcement material describes the features supported by NCP V7R8.1 MVS. Ask your IBM representative for this information if you have not already received a copy.

### 2.1 Basic Machine-Readable Material

The distribution medium for this program is 9-track magnetic tape (written at 6250 BPI), 3480 cartridge, or 4mm cartridge. The tape or cartridge contains all the programs and data needed for installation. It is installed using SMP/E, and is in SMP/E RELFILE format. See 6.0, "Installation Instructions" on page 30 for more information about how to install the program.

Figure 1 describes the tape or cartridge.

PSP Buckets are identified by UPGRADEs, which specify product levels, and SUBSETs, which specify the FMIDs for a product level. The UPGRADE and SUBSET values for NCP V7R8.1 MVS are:

## 5.0 Installation Requirements and Considerations

The following sections identify the system requirements for installing and activating NCP V7R8.1 MVS. The following terminology is used:

- *Driving system*: the system used to install the program.
- *Target system*: the system on which the program is installed.

In many cases, the same system can be used as both a driving system and a target system. However, you may want to set up a clone of your system to use as a target system by making a separate IPL-able copy of the running system. The clone should include copies of all system libraries that SMP/E updates, copies of the SMP/E CSI data sets that describe the system libraries, and your PARMLIB and PROCLIB.

Some cases where two systems should be used include the following:

- When installing a new level of a product that is already installed, the new product will delete the old one. By installing onto a separate target system, you can test the new product while still keeping the old one in production.
- When installing a product that shares libraries or load modules with other products, the installation can disrupt the other products. Installing onto a test system or clone will allow you to assess these impacts without disrupting your production system.

## 5.2 Target System Requirements

This section describes the environment of the target system required to install and use NCP V7R8.1 MVS.

NCP V7R8.1 MVS installs in the NCP (P004) SREL.

### 5.2.1 Machine Requirements

This program operates on any IBM 3745 Communication Controller. The Controller Load and Dump Program (CLDP) is used to load and dump the 3745 when attached to the host via an OEMI channel, ESCON channel, or remotely via a 3745 base frame SDLC link through another controller. For other connections, loads and dumps require an active NCP and an owning VTAM. The MODIFY DUMP and MODIFY LOAD transfer facility commands of the owning VTAM are then used to load and dump the IBM 3745. For more information, refer to *IBM 3720/3745 Communication Controllers Remote Loading/Activation Guide* (SA33-0161).

The IBM 3745 Communication Controller must have the appropriate features and microcode level installed when the IBM 3745 expansion frame, the IBM 3746 Model 900, is installed. The IBM 3746 Model 900 provides ESCON attachment capability for the IBM 3745, as well as additional higher performance token-ring adapters, communication line adapters, and frame relay capability on the communication line adapters for the IBM 3745. The communication line adapters support SDLC, frame relay, X.25 NPSI with NPSI V3R8 or later, and X.25 ODLC.

When the 3746 Model 900 is attached, the NCP V7R8.1 3746 Model 900 feature license is required at the appropriate usage tier level.

For 3746 Model 900 IP internal coupling with NCP, the 3746 Model 900 Network Node Processor Feature 5022 or 5122, the IP Routing Feature 5033, and either Feature 5810 or Feature 5811 are required.

For 3746 Model 900 Frame Relay and ISDN DYNWIND Keyword expanded options, either Feature 5810 or Feature 5811 is required.

For the higher performance frame relay capability on the communication line adapters in the 3746 Model 900, either Feature 5810, Feature 5811, or ECA number 134 is required.

For Automatic Network Routing (ANR) over ESCON, either Feature 5810, Feature 5811, or ECA number 137 is required.

For High Performance Routing (HPR) using frame-relay on the communication line adapters in the 3746 Model 900, either Feature 5810, Feature 5811, or ECA number 137 is required.

For 3746 Model 900 processor performance and storage utilization NPM information, either Feature 5810, Feature 5811, or ECA number 137 is required.

For 3746 Model 900 TIC3 utilization NPM information, either Feature 5810, Feature 5811, or ECA number 137 is required.

For 3746 Model 900 communication line adapter X.25 NPSI support, either Feature 5810, Feature 5811, or ECA number 137 is required.

For 3746 Model 900 frame-relay Boundary Access Node (BAN) support, either Feature 5810, Feature 5811, or ECA number 138 is required.

For 3746 Model 900 frame-relay SAP multiplexing support, either Feature 5810, Feature 5811, or ECA number 138 is required.

For 3746 Model 900 frame-relay HPR NPM information, either Feature 5810, Feature 5811, or ECA number 138 is required.

For 3746 Model 900 Network Node tier C level support, either Feature 5810, Feature 5811, or ECA number 146 (EC # D22560D) is required.

For 3746 Model 900 X.25 support, either Feature 5810, Feature 5811, or ECA number 146 (EC # D22560D) is required.

A microcode EC for the 3745 is required for the Dynamic Internet Protocol routing function of this program when using the Ethernet Subsystem (ESS). Following are the minimum 3745 microcode EC levels to support this function:

The NCP V7R8.1 minimum size load module may exceed 1 megabyte. This is supported in base microcode levels for the x1A and 17A models. Patches exist for x10 and 1x0 models. Please see Technical Data Recording (TDR) H124890 for more information.

### 5.2.1.1 Controller RPQs

NCP V7R8.1 MVS, through the Airline Control Interconnect feature, provides support for the 3745 RPQs listed in Figure 12.

Airline Control (ALCI) RPQ is a free feature offered in NCP V7R8.1. Previously, you were required to license, order, and install the ALCI RPQ as a separate feature. Starting with NCP V7R6, the ALCI RPQ has been incorporated into the NCP base product tape. You are no longer required to order and install separate media for ALCI. You must continue to license the ALCI feature as in previous releases.

### 5.2.2.3 Toleration/Coexistence Requisites

A toleration/coexistence requisite is defined as a product which must be present on a sharing system. ## 6.0 Installation Instructions

This chapter describes the installation method and the step-by-step procedures to install and to activate the functions of NCP V7R8.1 MVS.

Please note the following:

- If you want to install NCP V7R8.1 MVS into its own SMP/E environment, consult the SMP/E manuals for instructions on creating and initializing the SMPCSI and the SMP/E control data sets.
- Sample jobs have been provided to help perform some or all of the installation tasks. The SMP/E jobs assume that all DDDEF entries required for SMP/E execution have been defined in the appropriate zones.
- The SMP/E dialogs may be used instead of the sample jobs to accomplish the SMP/E installation steps.

---

### 6.1 Installing NCP V7R8.1 MVS

#### 6.1.1 SMP/E Considerations for Installing NCP V7R8.1 MVS

This release of NCP V7R8.1 MVS is installed using the SMP/E RECEIVE, APPLY, and ACCEPT commands. The SMP/E dialogs may be used to accomplish the SMP/E installation steps.

#### 6.1.2 SMP/E Options Subentry Values

The recommended values for some SMP/E CSI subentries are shown in Figure 53. Use of values lower than these may result in failures in the installation process. DSSPACE is a subentry in the GLOBAL options entry. PEMAX is a subentry of the GENERAL entry in the GLOBAL options entry. Refer to the SMP/E manuals for instructions on updating the global zone.

## 6.1.4 Perform SMP/E RECEIVE

Edit and submit sample job NCPRECEV to perform the SMP/E RECEIVE for NCP V7R8.1 MVS. Consult the instructions in the sample job for more information.

NOTE: If you obtained NCP V7R8.1 MVS as part of a CBPDO, you can use the RCVPDO job found in the CBPDO RIMLIB data set to RECEIVE the NCP V7R8.1 MVS FMIDs as well as any service, HOLDDATA,

or preventive service planning (PSP) information included on the CBPDO tape. For more information, refer to the documentation included with the CBPDO.

**Expected Return Codes and Messages:**

NCPRECEV job ends with return code equal zero (RC=0).

## 6.1.5 Allocate SMP/E Target and Distribution Libraries

Edit and submit sample job NCPALLOC to allocate the SMP/E target and distribution libraries for NCP V7R8.1 MVS. Consult the instructions in the sample job for more information.

**Expected Return Codes and Messages:**

NCPALLOC job ends with return code equal zero (RC=0).

## 6.1.6 Create DDDEF Entries

Edit and submit sample job NCPDDDEF to create DDDEF entries for the SMP/E target and distribution libraries for NCP V7R8.1 MVS. Consult the instructions in the sample job for more information.

**Expected Return Codes and Messages:**

NCPDDDEF job ends with return code equal zero (RC=0). If any of the DDDEF entries already exist, the NCPDDDEF job will end with return code of 8 (RC=8). Check the output to determine the cause of the non-zero return code.

## 6.1.7 Perform SMP/E APPLY

Edit and submit sample job NCPAPPCK to perform an SMP/E APPLY CHECK for NCP V7R8.1 MVS. Consult the instructions in the sample job for more information.

To receive the full benefit of the SMP/E Causer SYSMOD Summary Report, do *not* bypass the following on the APPLY CHECK: PRE, ID, REQ, and IFREQ. This is because the SMP/E root cause analysis identifies the cause only of **ERRORS** and not of **WARNINGS** (SYSMODs that are bypassed are treated as warnings, not errors, by SMP/E).

Once you have taken any actions indicated by the APPLY CHECK, edit and submit sample job NCPAPPLY to perform the APPLY.

**Note:** The GROUPEXTEND operand indicates that SMP/E apply all requisite SYSMODs. The requisite SYSMODS might be applicable to other functions.

**Expected Return Codes and Messages from APPLY CHECK:**

## **6.1.8 Perform SMP/E ACCEPT**

Edit and submit sample job NCPACCK to perform an SMP/E ACCEPT CHECK for NCP V7R8.1 MVS. Consult the instructions in the sample job for more information.

To receive the full benefit of the SMP/E Causer SYSMOD Summary Report, do *not* bypass the following on the ACCEPT CHECK: PRE, ID, REQ, and IFREQ. This is because the SMP/E root cause analysis identifies the cause only of **ERRORS** and not of **WARNINGS** (SYSMODs that are bypassed are treated as warnings, not errors, by SMP/E).

Before using SMP/E to load new distribution libraries, it is recommended that you set the ACCJCLIN indicator in the distribution zone. This will cause entries produced from JCLIN to be saved in the distribution zone whenever a SYSMOD containing inline JCLIN is ACCEPTed. For more information on the ACCJCLIN indicator, see the description of inline JCLIN in the SMP/E manuals.

Once you have taken any actions indicated by the ACCEPT CHECK, edit and submit sample job NCPACCEP to perform the ACCEPT.

**Note:** The GROUPEXTEND operand indicates that SMP/E accept all requisite SYSMODs. The requisite SYSMODS might be applicable to other functions.

### **Expected Return Codes and Messages from ACCEPT CHECK:**

NCPACCK job ends with return code equal zero (RC=0).

### **Expected Return Codes and Messages from ACCEPT:**

NCPACCEP job ends with return code equal zero (RC=0).

If PTFs containing replacement modules are being ACCEPTed, SMP/E ACCEPT processing will linkedit/bind the modules into the distribution libraries. During this processing, the Linkage Editor or Binder may issue messages documenting unresolved external references, resulting in a return code of 4 from the ACCEPT step. These messages can be ignored, because the distribution libraries are not executable and the unresolved external references will not affect the executable system libraries.

## 6.2 Activating NCP V7R8.1 MVS

The SSP, NCP, and controller-resident NCP-related products share post-installation procedures. After you install all products needed for the system environment, your system is ready for post-installation maintenance processing. If a PTF cumulative service tape is included with the order, install the maintenance now.

If PTFs containing replacement modules are being ACCEPTed, SMP/E ACCEPT processing will linkedit/bind the modules into the distribution libraries. During this processing, the Linkage Editor or Binder might issue messages documenting unresolved external references, resulting in a return code of 4 from the ACCEPT step. These messages can be ignored because the distribution libraries are not executable and the unresolved external references will not affect the executable system libraries.

To re-linkedit the NCP load modules under SMP/E, you may need to add a LOADNCP DD statement to the DDDEF job. The LOADNCP DD statement must point to the library that contains your NCP load modules. For an example, see the SYSLMOD DD statement in the *Network Control Program, System Support Programs, and Emulation Program Generation and Loading Guide*.

Run the HONE Configurator to determine your new load module size after installation. Storage requirements and load module size usually change from release to release, which affects the number of buffers in the buffer pool. Contact your IBM representative for assistance.

### 6.2.1 For an NCP-Only System

If you are installing an NCP-only system and have not already installed the SSP product, refer to the SSP program directory for product information and installation instructions. If you have already installed SSP, you have completed installation for an NCP-only system, and you are ready to generate NCP.

### 6.2.2 For a PEP (NCP and EP) System

If you are installing a PEP system and have not already installed the SSP or EP product, refer to the appropriate program directory for product information and installation instructions. You should install these products before generating NCP. If you have already installed both the SSP and EP products, you have completed installation of a PEP system, and you are ready to generate NCP and PEP.

### 6.2.3 For an EP Standalone System

If you are installing an EP standalone environment you must install NCP and EP. After NCP is installed, refer to the EP program directory for EP product information and installation instructions. If you have not installed SSP, refer to the SSP program directory for product information and installation instructions. If you have installed NCP, EP, and SSP, you have completed installation for an EP standalone system and you are ready to generate EP.
