## About This Publication

This publication is designed to help programmers, analysts, and administrators who install, customize, or maintain Print Services Facility™ (PSF) for z/OS® (hereafter referred to as PSF) as a component of a trusted computing base.<sup>1</sup>

This publication describes the PSF function called *print labeling*. This function can be used to produce printed output containing special labels. These labels can be used for security purposes or other installation-defined purposes.

**Note:** Print labeling can be done with PSF even if PSF is not a part of a trusted computing base.

## Who Should Read This Publication

You should use this publication if you are a system programmer, a system analyst, a security administrator, a security auditor, or an application programmer who is responsible for data security.

You should be familiar with the material contained in *PSF for z/OS: Customization* and *PSF for z/OS: User's Guide* before attempting any of the procedures described in this publication.

---

## How This Publication Is Organized

This publication is intended to help you perform the tasks in Table 2 on page 7. The information in this publication must not be used for programming purposes.

This publication is organized so that you can read it sequentially or refer directly to individual tasks.

A notices section, glossary, bibliography, and index are included. The bibliography lists the publications containing additional information about the system, hardware, or software used by PSF, or about installation and maintenance.

## Understanding the Syntax Notation Used in This Publication

The following rules apply to syntax examples and coding illustrations throughout this publication:

- The uppercase letters are to be entered as shown; however, you do not need to type them in uppercase.
- The variable data you must provide is printed in italics. Enter specific data to replace the characters in italics; for example, for *PRTnnnn* you could enter PRT2.
- Do not enter any of the following symbols as part of a parameter or an option:

Vertical bar	
Underscore	—
Braces	{ }
Brackets	[ ]

- A vertical bar between two values means that you are to select only one of the values.
- If one value in a set of values is underscored, that value is the default—that is, the value that PSF uses if no option is specified.
- If values are enclosed in braces { }, one or the other of the values in the braces must be selected.
- If a value is enclosed in brackets [ ], you do not have to select that value.

## Using LookAt to View Message Explanations

LookAt is an online facility that you can use to view explanations for most IBM messages and some system abends and codes. Using LookAt to find information is faster than a conventional search because in most cases LookAt goes directly to the message explanation.

To find a message explanation in LookAt, you enter the message identifier (for example, APS708I or APS\*). Some messages have information in more than one document. For those messages, LookAt displays a list of documents that contain the message.

# Chapter 1. Introducing the Print Labeling Function

This chapter introduces the concept of print labeling and explains how PSF for z/OS operates within a secure computing environment.

## Understanding Print Labeling

You can place identification labels on each page of printed output with the PSF function called print labeling. An identification label can be composed of text, graphics, or a combination of both. Identification labels can be used for security information, such as a TOP SECRET security level, or for other installation-defined purposes. Identification labels can be placed on the top, bottom, or sides of all pages within a job. Up to eight labels can be defined to print on every page of the job.

An identification label is positioned on the page by using a resource called a security overlay. The overlays, as well as the resources used by the overlays, such as fonts and page segments, are stored in special security libraries.

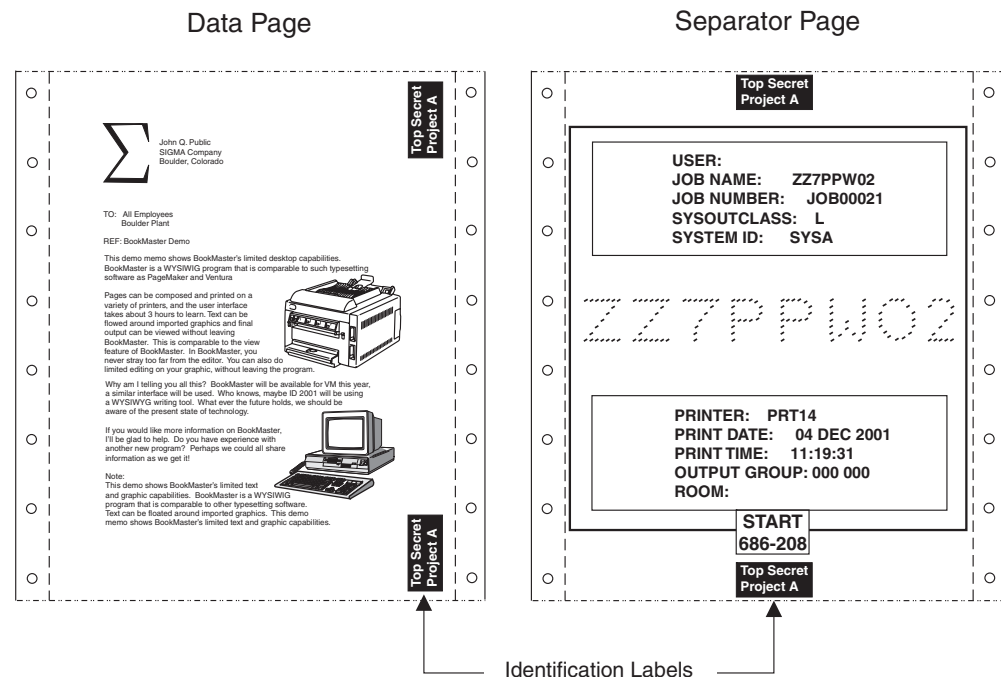


Figure 1. Print Labeling. Identification labels can be placed on the top, bottom, or sides of all pages within a job. This example shows a page from two different jobs.

Print labeling can be applied to data pages, as well as to separator pages. Figure 1 shows labeling applied to a data page from one job and a separator page from another job.

The two types of print labeling are *guaranteed print labeling* and *nonguaranteed print labeling*. Guaranteed print labeling works with a subset of Advanced Function Presentation™ (AFP) printers and ensures the integrity of the identification label by preventing the user from changing the label. Nonguaranteed print labeling works

on most AFP printers, but the integrity of the identification labels cannot be guaranteed. For a list of printers that support print labeling, see “Printer Support in PSF” on page 9.

Print labeling works like this:

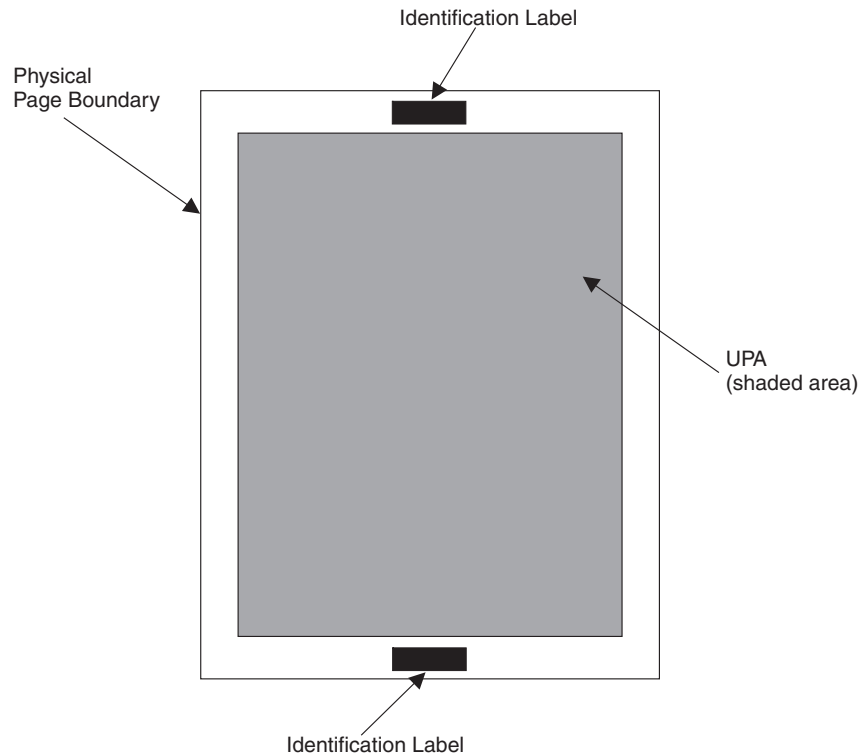
1. The user submits a print request that uses data and resources from host libraries. The print request has a security label associated with it. The label is a combination of both the security level and the security class.
2. Resource Access Control Facility (RACF<sup>®</sup>), a component of z/OS Security Server, checks to ensure that the user’s security label matches the security labels of all requested user data or user resources. If the labels match, the data is placed on the spool.
3. PSF formats the data and resources by using the security label of the print job to apply the appropriate security overlays to all pages of the printed output.

The integrity of the identification label is ensured by the positioning of the label in an area of the page where user data cannot be placed. To enforce this, the valid printable area of a form for user data is reduced by the definition of a user-printable area.

## User-Printable Area

The user-printable area (UPA) is the area on the page that contains all user-generated data. If an attempt is made to print user-generated data outside the UPA, an exception condition occurs. Identification labels are placed outside of the UPA, but within the valid printable area of the form. Figure 2 on page 3 shows a layout of where an identification label can be placed.

When guaranteed print labeling is enabled, an appropriate UPA must be defined by the system programmer for each paper size that can be used to print data with a particular identification label. Different UPAs can be defined for the same paper size when different identification labels are used.



*Figure 2. Placing Identification Labels on the Physical Page.* Identification labels should be placed outside the UPA but must be placed within the physical page boundaries.

For a template that you can use to lay out your pages and define the UPA, see Appendix A, “Security Page Layout,” on page 29.

---

## Distributing Secure PSF Output

PSF prints a randomly generated number for each job on the header and the trailer pages of the job if guaranteed print labeling is being performed. The printer operator matches the number on the header page to the number on the trailer page before distributing the job output. By ensuring that the numbers match, the printer operator ensures output security. Figure 3 on page 4 illustrates the printed numbers.



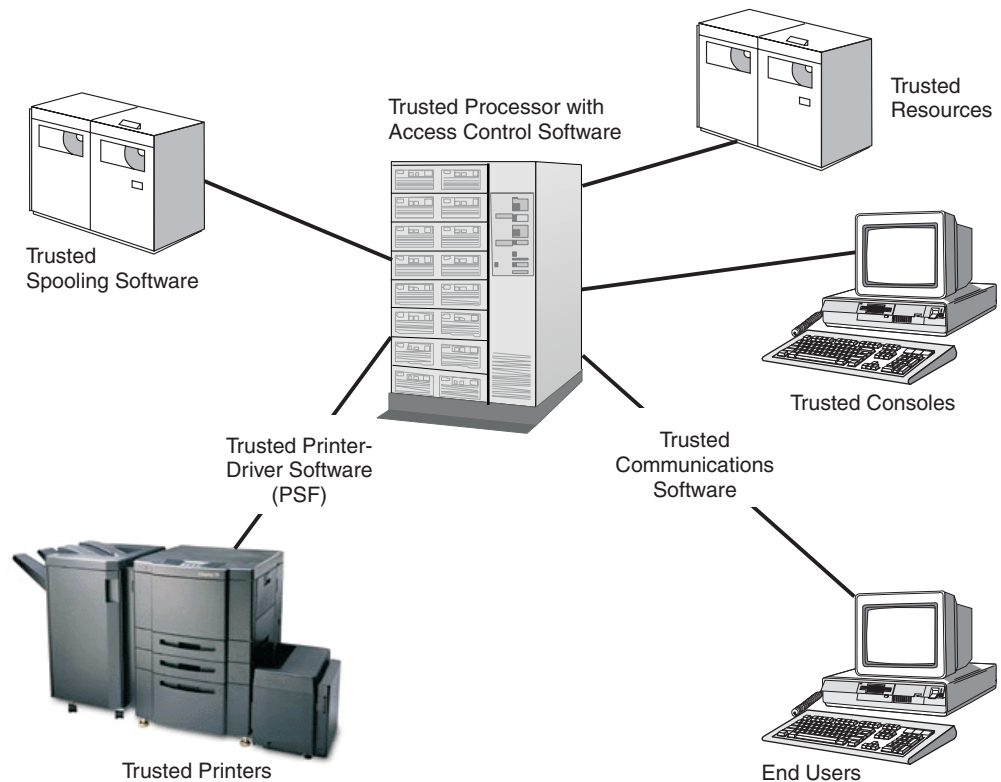


Figure 4. Typical Components of a Trusted Computing Base. Your installation might have different components installed.

## Trusted Software

*Trusted software* is the software portion of the trusted computing base. It includes:

### Access control software

Access control is regulated by RACF, which:

- Authorizes user sessions based on user ID.
- Authorizes resource access.
- Ensures that only users identified to RACF can access the processor or resources.

For more information about how to protect processing with RACF, see *z/OS Security Server RACF Security Administrator's Guide*.

### Trusted spooling software

In a trusted computing base, spool files are protected through RACF and your spooling software. For example, in z/OS, the Job Entry Subsystem (JES) spool is protected by activating the RACF JESSPOOL security class and by defining RACF profiles. For information about defining PSF-related RACF profiles, see "Using RACF with PSF for z/OS" on page 17.

### Trusted printer-driver software

In a trusted computing base, secure printed output is controlled through PSF (the printer-driver software) and RACF. Output from a trusted printer has identification labels printed on each page.

### **Trusted communications software**

In a trusted computing base, communications software is used to connect input and output devices to the main processor. For example, Communications Server: IP Services can be used to connect end-user terminals to the main processor so users communicate with one another.

In a trusted computing base, communication through networking software is controlled through RACF, and communication between users can be restricted or prohibited based on defined security clearances. See your networking software documentation for more information about controlling network access with RACF and for defining security clearances for end-user terminals.

### **Trusted resources**

In a trusted computing base, some resources are defined as security resources and are managed differently from other resources. For example, fonts, overlays, and page segments that are used to print identification labels are stored in secure libraries, and only the printer driver can access these resources for printing.

## **Trusted Hardware**

*Trusted hardware* is the set of equipment protected through RACF in the trusted computing base. It includes:

### **Trusted processor**

In a trusted computing base, the main processor provides access control for admittance to all resources and end-user processing. Communication between trusted and nontrusted processors is restricted.

### **Trusted printers**

In a trusted computing base, a trusted printer is one that supports guaranteed print labeling. For more information on guaranteed print labeling and printers that support guaranteed print labeling, see “Printer Support in PSF” on page 9.

In addition, a trusted printer is located in a controlled area. Only the printer operator is allowed to distribute output to the user.

### **Trusted console**

In a trusted computing base, a trusted console is a computer terminal that is defined to RACF with a security label. In addition, a trusted console is located in a controlled area where only authorized personnel are allowed to access the console.

A trusted console, or *security console*, can still be restricted from accepting certain console operator commands. For example, in z/OS, JES3 commands are grouped into command authority levels, and consoles can be defined to accept only certain levels of JES3 commands from the console operator. For more information about defining a console to RACF, see the RACF documentation for your operating system.

For information about diverting PSF messages from a master console to a security console, see “Defining a Security Console” on page 15.

## Users

In a trusted computing base, the user must be defined to RACF by using a security level and a security class. Both the security level and the security class make up the *security label* of the user. Only users who have a security label assigned to the user terminal can use the trusted computing base.

## Chapter 2. Using Print Labeling

This chapter describes how to enable, customize, and maintain the print labeling function of PSF for z/OS. The procedures, examples, and parameters given in this chapter apply only to a z/OS operating system.

While using this chapter, you can find helpful information in these publications:

### Installing PSF

Install PSF as instructed in the *Program Directory for Print Services Facility for z/OS*, GI10-0281, which is included with the PSF licensed program tapes. This directory contains information about the microcode levels for specific printers. You need to make sure that the appropriate level of microcode is installed on your printer before your printer can support guaranteed print labeling.

### Printer Support in PSF

AFP printers can support guaranteed print labeling or nonguaranteed print labeling. To determine the type of print labeling your printer supports in PSF for z/OS, use the display printer information function. If the Define User Area is listed in the DEVICE CONTROL COMMAND Set Vector of the Sense Type and Model (STM), the printer supports guaranteed print labeling; if it is not, the printer supports nonguaranteed print labeling. For more information about the display printer information function, see *PSF for z/OS: Customization*.

For more information about guaranteed print labeling and nonguaranteed print labeling, see "Enabling Print Labeling" on page 16.

### Designing Pages for Print Labeling

These are the steps required to design pages for print labeling:

1. Identify any fonts or page segments that you want to use in the identification label. For information about identifying fonts and page segments, see “Defining Security Resource Libraries” on page 15 and “Defining Data Definition Names in the PRINTDEV Statement” on page 21.
2. Construct a page layout. See Appendix A, “Security Page Layout,” on page 29 for a page layout tool.
3. Create security overlays as needed. See “Creating Security Overlays.”
4. Create a security definitions library (allocate and define members). Each combination of security label, paper size, and page top must be defined to PSF in a member of a security definitions library. To define members in a security definitions library, see “Defining a Security Definitions Library” on page 11.

## Creating Security Overlays

You should create at least one security overlay for each security label that you are using on your system. The same overlay can be used on different paper sizes and orientations but the overlay must be carefully designed, taking into consideration the media origin and the printable area differences. More than one security overlay can be created for each combination of security label, paper size, and orientation, if desired.

Security overlays are created as you would create other overlays, but RACF is used to protect overlays that reside in a secure library from any unauthorized modification. For example, a user of Overlay Generation Language (OGL) would have to be RACF-authorized to access an overlay in a secure library. See your RACF documentation for more information about how users are authorized to access secure libraries. For more information about creating overlays, see *Overlay Generation Language User’s Guide and Reference*.

### Printing with Security Overlays

Printing security overlays is not specified with a form definition but with the SECOVLY option. This option is coded in a member of the security definitions library. See “Defining a Security Definitions Library” on page 11 for more information.

---

## Allocating the Security Definitions Library

The *security definitions library* is a partitioned data set or a series of concatenated partitioned data sets. A security definitions library contains separate definitions for each type of security label available on the system. A single member contains the definitions for one security label that is used with all paper sizes and page orientations. For example, a security definitions library called SECURE.SECDEFS could contain two members, named TOPSEC and UNCL. The member SECURE.SECDEFS(TOPSEC) could contain definitions for printing a top secret identification label. The member SECURE.SECDEFS(UNCL) could contain definitions for printing an unclassified identification label.

A member of a security definitions library contains the size and origin of the user-printable area (UPA) for each paper size and page orientation used by the printer. The security definitions library can optionally contain the names of any security overlays.

You should define the minimum number of paper sizes required for each security label. This reduces PSF search time. For example, you can create a security definitions library for all of your printers that use cut-sheet paper and another library for all of your printers that use continuous-forms paper.

Names used to identify the security definitions library are defined in a PSF startup procedure. The DD statement is used to associate a security definitions library name to the printer that uses that library. See Figure 16 on page 19 for an example of how a DD statement is used to refer to a security library name.

## Security Definitions Library Attributes

You should allocate a security definitions library with the attributes listed in Figure 5.

**Note:** The security definitions library cannot have records that contain machine or American National Standards Institute (ANSI) control characters and cannot use the track overflow feature.

---

## Defining a Security Definitions Library

You should define a member in the security definitions library for each security label that you need.

## Syntax for a Security Definitions Member

Figure 6 illustrates the syntax for a security definitions library member.

The parameters and values for a security definitions library member are:

**{PAPERNAME *papername* | PAPERSIZ *width\_value height\_value*}**

Specifies the size of the paper. You must use either PAPERNAME or PAPERSIZ.

PAPERNAME specifies the system-defined paper names for each paper size. See Appendix B, “PAPERNAME Table for System-Defined Paper Names,” on page 31 for a list of valid names and the dimensions for each system-defined paper name.

PAPERSIZ specifies the width and height of the paper and the units of measurement, either in inches (IN) or in millimeters (MM). The PAPERSIZ parameter should be used if the size of the paper loaded in the printer does not correspond to one of the PSF system-defined paper names.

The valid values for inches can be from 0 to 22.75. The valid values for millimeters can be from 0 to 577.97. The values do not need to be in the same units and are entered as follows (the decimal point is optional for integer values):

*nnn.nn* {IN | MM}

See Figure 7 on page 14 for an example of this parameter.

**Note:** Make sure you have a paper definition for every size of paper that might be installed on a printer.

[ TOP { NARROW | WIDE } ]

Specifies which edge of the paper is the top by identifying whether the media origin<sup>2</sup> is located at the top-left corner of a narrow or wide edge of the paper. The TOP parameter has two options:

- NARROW is the default and specifies that the security overlays and UPA in this security definition entry use the top-left corner of a narrow edge of the paper as the media origin.
- WIDE specifies that the security overlays and UPA in this security definition entry use the top-left corner of a wide edge of the paper as the media origin.

For continuous-forms printers, a security definitions member can contain both a NARROW and WIDE entry if:

- Both narrow and wide forms are used for the security label.<sup>3</sup>
- The form definition contains page-presentation and print-direction controls that change the default media origin.

For cut-sheet printers, only one entry (NARROW) is needed. Because the media origin for cut sheets is always the top-left corner of a narrow edge, the WIDE option is ignored for cut-sheet forms.

Determine whether to use the WIDE or NARROW entry for continuous-forms printers:

- WIDE for wide forms if the form definition contains LANDSCAPE ACROSS or PORTRAIT DOWN controls
- WIDE for narrow forms if the form definition contains PORTRAIT ACROSS or LANDSCAPE DOWN controls
- NARROW for narrow forms if the form definition contains PORTRAIT ACROSS or LANDSCAPE DOWN controls
- NARROW for wide forms if the form definition contains LANDSCAPE ACROSS or PORTRAIT DOWN controls

For more information about the page-presentation and print-direction controls in a form definition, see *Page Printer Formatting Aid: User's Guide*.

See Figure 7 on page 14 for an example of this parameter.

[ UPAORG *xorg\_value yorg\_value* ]

Specifies the origin, in inches (IN) or millimeters (MM), of the UPA.

The origin is expressed as horizontal offsets (*xorg*) and vertical offsets (*yorg*) from the media origin for a particular page size and origin.

The valid values for inches can be from 0 to 22.75. The valid values for millimeters can be from 0 to 577.97. The values do not need to be in the same units and are entered as follows (the decimal point is optional for integer values):

nnn.nn {IN | MM}

See Figure 7 on page 14 for an example of this parameter.

---

2. Media origin used by any security overlays or the media origin used by the UPA. For more information about media origins and the coordinate system used by AFP printers, see *Intelligent Printer Data Stream Reference*.

3. Narrow forms are those that have perforations on the shorter edge of the paper and tractor holes on the longer edge. Wide forms are those that have perforations on the longer edge of the paper and tractor holes on the shorter edge.

**Note:** This parameter is required if Restrict printable area=YES is specified (or is a default) in the Infoprint® Server Printer Inventory, SYSAREA=YES is specified (or is a default) in the PRINTDEV statement for the data set, or UPADIM is specified.

[ **UPADIM** *xlength\_value ylength\_value* ]

Specifies the size, in inches (IN) or millimeters (MM), of the UPA.

The size of the UPA is expressed as horizontal (*xlength*) and vertical (*ylength*) dimensions of the UPA for a particular page size and origin.

The valid values for inches can be from 0 to 22.75. The valid values for millimeters can be from 0.1 to 577.97. The values do not need to be in the same units and are entered as follows (the decimal point is optional for integer values):

nnn.nn {IN | MM}

See Figure 7 on page 14 for an example of this parameter.

**Note:** This parameter is required if Restrict printable area=YES is specified (or is a default) in the Infoprint Server Printer Inventory, SYSAREA=YES is specified (or is a default) in the PRINTDEV statement for the data set, or UPAORG is specified.

[ **SECOVLY** *name1 name2...name8* ]

Specifies the names of the overlays to be used for this security label on both the separator pages and the data pages.

One to eight overlays can be specified. These overlays must reside in a security overlay library.

See Figure 7 on page 14 for an example of this parameter.

**Notes:**

1. Overlay names are restricted to six characters; PSF appends a two-character prefix (O1).
2. If fonts or page segments are used in any of these overlays, the fonts must reside in a security font library and the page segments must reside in a security page-segment library.
3. This parameter is required if Label data pages=YES or Label separator pages=YES is specified in the Infoprint Server Printer Inventory, or DPAGELBL=YES or SPAGELBL=YES is specified in the PRINTDEV statement.

## Rules for Defining a Security Definitions Member

This list describes the rules for defining a single member in a security definitions library:

- For each PAPERNAME or PAPERSIZ parameter, up to two sets of TOP, UPAORG, UPADIM, and SECOVLY parameters can be specified, one for the TOP WIDE parameter and one for the TOP NARROW parameter. If duplicate parameters within a set are specified, the last option for that parameter is used.
- The TOP parameter, if present, must be specified before the SECOVLY, UPAORG, and UPADIM parameters that correspond to the TOP parameter.
- The UPAORG, UPADIM, and SECOVLY parameters can be specified in any order. Either SECOVLY or both the UPAORG and the UPADIM parameter must be specified. All three can be used together.
- Multiple parameters and options can be specified in a single record.

- The delimiters that separate the parameters and options are one or more consecutive blanks, or the end of the line.
- Comments can be entered in the security member by entering an asterisk (\*) as the first nonblank character in a line. The rest of the record is ignored. Comments cannot appear on the same line as the parameters or options.

**Note:** When the paper is to be cut after printing (for example, 2-up printing), you must take care to create secure overlays that appropriately label each of the subsheets.

## Sample Security Definitions Member

The member definition in Figure 7 is used when a SECLABEL of TOPSEC is specified in the print job JCL and can be used for two paper types.

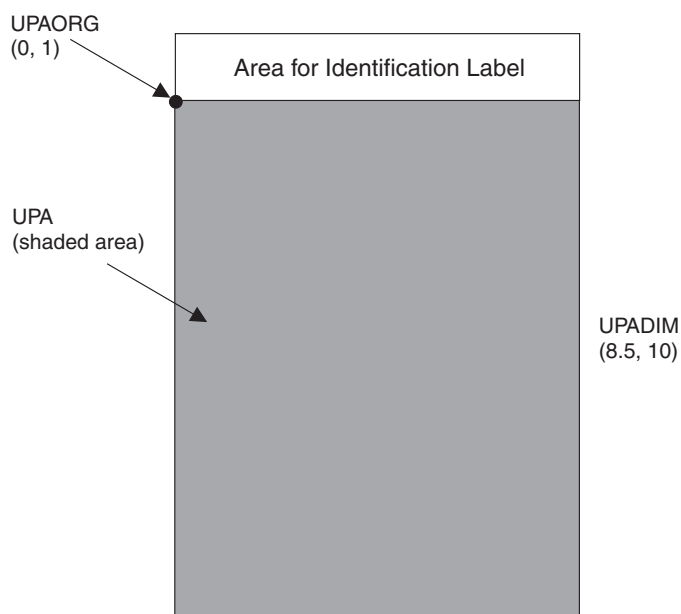


Figure 8. Page Layout for a Cut-Sheet Page

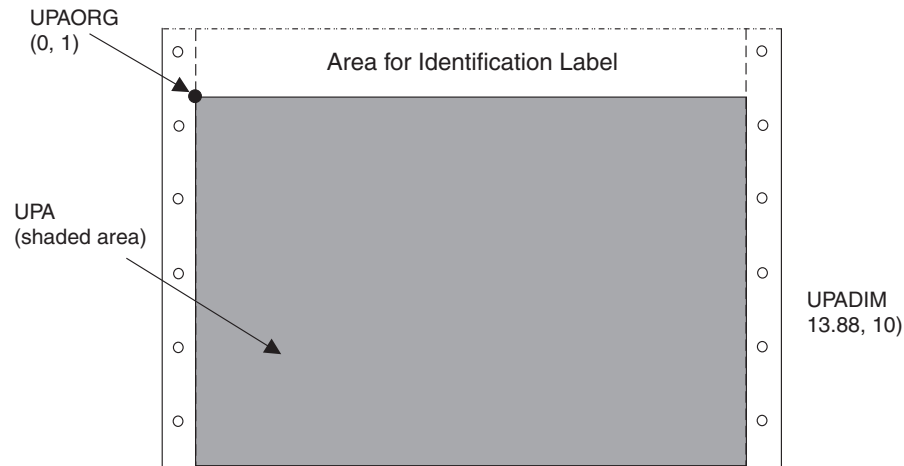


Figure 9. Page Layout for a Continuous Form

## Defining Security Resource Libraries

The three types of security resources are overlays, page segments, and fonts. These types of resources are stored in a secure library, and they are managed differently from other resources stored on the system. You should allocate a security resource library with the attributes listed in Table 3.

Table 3. Library Attributes for a Security Resource Library

Overlays and Page Segments	Fonts
DSORG=PO LRECL=8205 BLKSIZE=8209 RECFM=VBM	DSORG=PO LRECL=12284 BLKSIZE=12288 RECFM=VBM

Security overlays are produced for each security label defined. One or more security overlays can be defined for each size paper and page orientation being used. Security fonts and security page segments are those that are used within the security overlay. Security resource libraries are named in the PRINTDEV statement of the PSF startup procedure. See “Defining Data Definition Names in the PRINTDEV Statement” on page 21 for the syntax used in the PRINTDEV statement.

## Defining a Security Console

You can optionally receive security-related PSF messages at a security console, and you can optionally elect not to receive PSF security-related messages at the master console.

To route messages to a security console, change the ROUTCODE in the SYS1.PARMLIB(CONSOLxx) as illustrated in Figure 10 on page 16.

To stop security-related PSF messages from reaching the master console, change the ROUTCODE in SYS1.PARMLIB(CONSOLxx) as shown in Figure 11. With this option, all messages except security-related messages reach the master console.

## Assembling Separator Pages

Optional exits are provided if random numbering of separator pages is needed. For information about the exits that PSF provides, see *PSF for z/OS: Customization*.

The installation exits in Table 4 must be modified, assembled, installed, or link-edited with the REPLACE option to print random numbers on job separator pages.

Table 4. PSF Exit Routines in SYS1.SAMPLIB

Sample Routine	Description
APSUX01S	Source routine for security job headers.
APSUX02S	Source routine for security job trailers.

Either use the supplied source or modify the source to meet your needs. Figure 3 on page 4 illustrates the IBM-supplied security header and trailer pages in a printed format.

### Notes:

1. If APSUX01S and APSUX02S are used, they must replace APSUX01 and APSUX02. Ensure that APSUC01 and APSUC02 are not used. If they are, delete them because they will override APSUX01 and APSUX02.
2. Separator pages do not have a UPA.

---

## Enabling Print Labeling

PSF supports print labeling in two ways:

### Guaranteed print labeling

Guaranteed print labeling ensures the integrity of the identification label by preventing the user from changing the label. (See “Printer Support in PSF” on page 9 for information about determining whether a printer supports guaranteed print labeling.) Ensure that the RACF option PSFMPL is set according to Figure 13 on page 17.

### Nonguaranteed print labeling

Printers that do not support guaranteed print labeling can still print identification labels, but the integrity of the labels cannot be guaranteed. For nonguaranteed print labeling, you must:

1. Define the valid security labels to RACF as described in the *z/OS Security Server RACF Security Administrator's Guide*.



2. Activate security label checking through TSO commands as in Figure 12.

In addition, the RACF parameters shown in Figure 13 are optional for nonguaranteed print labeling. Other parameters in the PSF startup procedure are used to enable nonguaranteed print labeling. For more information, see “Updating Initialization Parameters” on page 19.

**Note:** PSF processing is different if print labeling is enabled. See “PSF Processing Differences When Using the Print Labeling Function” on page 18 for a list of differences.

## Using RACF with PSF for z/OS

Use RACF to activate PSFMPL and create RACF profiles.

**Note:** RACF CLASS PSFMPL must be refreshed after activating PSFMPL or creating new profiles.

- To activate print labeling, use SETROPTS. To set print labeling defaults to YES, use the RDEFINE command. RDEFINE creates RACF profiles. See Figure 13 for examples of using SETROPTS and RDEFINE.

- If you want to authorize a print job submitter to override printer defaults, issue the PERMIT commands in Figure 14 to add the user ID to the RACF profile.

- Whenever any of the commands shown in Figure 13 or Figure 14 are used, issue the REFRESH command illustrated in Figure 15 to refresh RACF.

## PSF Processing Differences When Using the Print Labeling Function

When using the print labeling function, PSF processing is different. The differences include:

- Security resources are accessed only from security libraries. A resource loaded in the printer from a security library cannot be used to print user data.
- User resources are accessed only from user resource libraries. A resource loaded in the printer from a user library cannot be used to print identification labels.
- Security resources are loaded into the printer as required by the print data set. They typically are not deleted at the end of a data set, except when:
  - The resource deletion exit is used to delete the resources.
  - A job-trailer page has been printed.

For more information about resource loading, deleting, and using installation exits, see *PSF for z/OS: Customization*.

- Suppression of trailer pages by using JES operator commands can impact printer performance because printer storage can be exceeded.
- An audit is performed whenever a data set is printed on a nonguaranteed printer.

### Printable Area Considerations

If PSFMPL is active, the Restrict printable area parameter in the Infoprint Server Printer Inventory or the SYSAREA parameter in the PRINTDEV statement defaults to YES.

If PSFMPL is not active, the Restrict printable area parameter in the Printer Inventory or the SYSAREA parameter in the PRINTDEV statement defaults to NO.

If you are using a nonguaranteed printer, these parameters must be set to NO or an abend occurs. For more information, see “Updating Print Labeling Parameters” on page 20.

## Updating Initialization Parameters

Before starting a PSF functional subsystem (FSS), you must have a cataloged PSF startup procedure in SYS1.PROCLIB or in a procedure library concatenated to the JES startup procedure. The PSF startup procedure specifies PSF initialization parameters that tell PSF where security resources and security definitions are located. Figure 16 lists a sample PSF startup procedure that includes parameters modified for print labeling.

## Updating Print Labeling Parameters

You can use the Infoprint Server Printer Inventory, the PRINTDEV statement in the PSF startup procedure, or the OUTPUT JCL statement to enable print labeling. Table 5 on page 21 lists the parameters that you can use.

Using the Printer Inventory is more efficient than using the PSF startup procedure because it avoids the need to restart all the printers in a startup procedure when changing parameters. Only the printer for which parameters are changed needs to be restarted.

### Keep in mind:

1. Parameters available in the Printer Inventory are ignored in the PSF startup procedure when the Printer Inventory is used. Therefore, if you use the Printer Inventory, you must specify the parameters in the Printer Inventory instead of the startup procedure.
2. You can use the Printer Inventory component of Infoprint Server without licensing the Infoprint Server feature of z/OS. For more information, see *z/OS Infoprint Server Printer Inventory for PSF*.

To use the Printer Inventory, you must specify the Printer Inventory name on the INV parameter in the PARM field of the EXEC statement for the startup procedure:

```
// EXEC PGM=APSPPIEP,PARM=('INV=piname')

```

where *piname* is the four-character name of the Printer Inventory that is specified in the Infoprint Server configuration file. For example,

```
// EXEC PGM=APSPPIEP,PARM=('INV=A0PI1')

```

specifies the default name of the Printer Inventory.

You can use either the Printer Inventory Definition Utility (PIDU) or the Printer Inventory ISPF panels to enable print labeling in the Printer Inventory (see *PSF for z/OS: Customization* for more information). When you are defining parameters on the ISPF panels, see the online help for information about each parameter.

## Defining Data Definition Names in the PRINTDEV Statement

These parameters are used to define security-related data definition names in the PRINTDEV statement:

**SFONTDD**=\*.ddname

Defines the default secure font library. This ddname is required if a security overlay references a font.

**SFONT240**=\*.ddname

Defines the secure font library for 240-pel fonts. This ddname is optional if all referenced 240-pel fonts are found in the default secure font library.

**SFONT300**=\*.ddname

Defines the secure font library for 300-pel fonts. This ddname is optional if all referenced 300-pel fonts are found in the default secure font library.

**SOVLYDD**=\*.ddname

Defines the default secure overlay library. This ddname is required if a security overlay is used to print identification labels.

**SOVLY240=\*.ddname**

Defines the secure overlay library for overlays that print best at 240-pel resolution. This ddname is optional if all such overlays are found in the default secure overlay library.

**SOVLY300=\*.ddname**

Defines the secure overlay library for overlays that print best at 300-pel resolution. This ddname is optional if all such overlays are found in the default secure overlay library.

**SPSEGDD=\*.ddname**

Defines the default secure page segment library. This ddname is required if a security overlay references a page segment.

**SPSEG240=\*.ddname**

Defines the secure page segment library for page segments that print best at 240-pel resolution. This ddname is optional if all such page segments are found in the default secure page segment library.

**SPSEG300=\*.ddname**

Defines the secure page segment library for page segments that print best at 300-pel resolution. This ddname is optional if all such page segments are found in the default secure page segment library.

**SDEFDD=\*.ddname**

Defines the default security definitions library. This ddname is required for print labeling.

**SDEF240=\*.ddname**

Defines the security definitions library for printing at 240-pel resolution. This ddname is optional if all such page segments are found in the default security definitions library.

**SDEF300=\*.ddname**

Defines the security definitions library for printing at 300-pel resolution. This ddname is optional if all such page segments are found in the default security definitions library.

These parameters refer to the libraries named in the startup procedure; see Figure 16 on page 19.

**Note:** Even if you used the Printer Inventory to enable print labeling, you must still specify these parameters in the PRINTDEV statement.

---

## Submitting a Print Job that Includes Identification Labels

After you have defined a security definitions library, updated PSF initialization parameters, and created security resources, you are ready to submit a print job. To submit a print job and have that job print with the correct identification label, follow this procedure to ensure that there is a member in the security definitions library with the same name as each SECLABEL that has been defined to RACF by the security administrator:

1. The security administrator defines a set of security labels to be used by the installation.
2. The security administrator associates SECLABELs with every user on the system.
3. The print administrator creates a member in the security definitions library to match the name of every SECLABEL defined to the system.

4. The user submits the job, the user's SECLABEL is matched and the appropriate security labeling is printed on the user's output.

For example, if you want to print the identification label associated with the security label of TOPSEC, you would specify SECLABEL=TOPSEC in the job card and PSF would use the member named SECURE.SECDEFS(TOPSEC) to find the security overlay identified for that security label.

Figure 17 shows an example of using the SECLABEL parameter in the job card. Figure 7 on page 14 shows an example of the definitions used in SECURE.SECDEF(TOPSEC).

## Overriding Print Labeling Defaults

If authorized by RACF, you can use these JCL keywords in the OUTPUT statement to change the definition of print labeling:

### DPAGELBL=YES|NO

Indicates whether a label is printed on each data page.

### SYSAREA=YES|NO

Indicates whether the printable area is restricted to the system-defined UPA.

If SYSAREA=YES is specified, any attempt to print outside the UPA results in error messages.

If your printer does not support guaranteed print labeling, use SYSAREA=NO. To determine if your printer supports guaranteed print labeling, see “Printer Support in PSF” on page 9.

Figure 18 shows an example of the OUTPUT statement used to override PSF defaults.

## Maintaining PSF for z/OS with Print Labeling Enabled

The following sections are used to maintain PSF when print labeling is enabled.

## Auditing PSF Printing

PSF uses the SMF type 6 record to audit certain events that can indicate a security exception. Only one record is written per data set, but the record can contain numerous conditions.

The following information is included in the SMF type 6 record to support print labeling:

- Indicator that flags JCL keywords that were in effect during printing
- Indicator that flags a successful print operation
- Indicator that flags an error that occurred during overlay processing
- Indicator that flags a hardware error that occurred
- Indicator that flags printed job-trailer pages
- Indicator that flags printed job-header pages
- Indicator that flags that the user suppressed data-page labeling
- Indicator that flags that the user suppressed UPA enforcement
- Identifier for the job or group identifier for the data set
- Identifier for the page definition name
- Identifier for the form definition name
- Identifier for the number of security overlays used
- Identifier for the number of security fonts used
- Identifier for the number of security page segments used

See *PSF for z/OS: Customization* for more information about the SMF type 6 record that PSF generates.

## Interpreting Security-Related Messages

If you receive a PSF error message that relates to print labeling, see *PSF for z/OS: Messages and Codes* for more information.

PSF security-related messages are received at these locations:

- Within a print job
- At the security console
- At the master console

A PSF message number can be placed in these JES messages:

- HASP704
- IAT706I

## Diagnosing Print Labeling Problems

The problems in Table 6 on page 25 can occur when you are using the print labeling function.

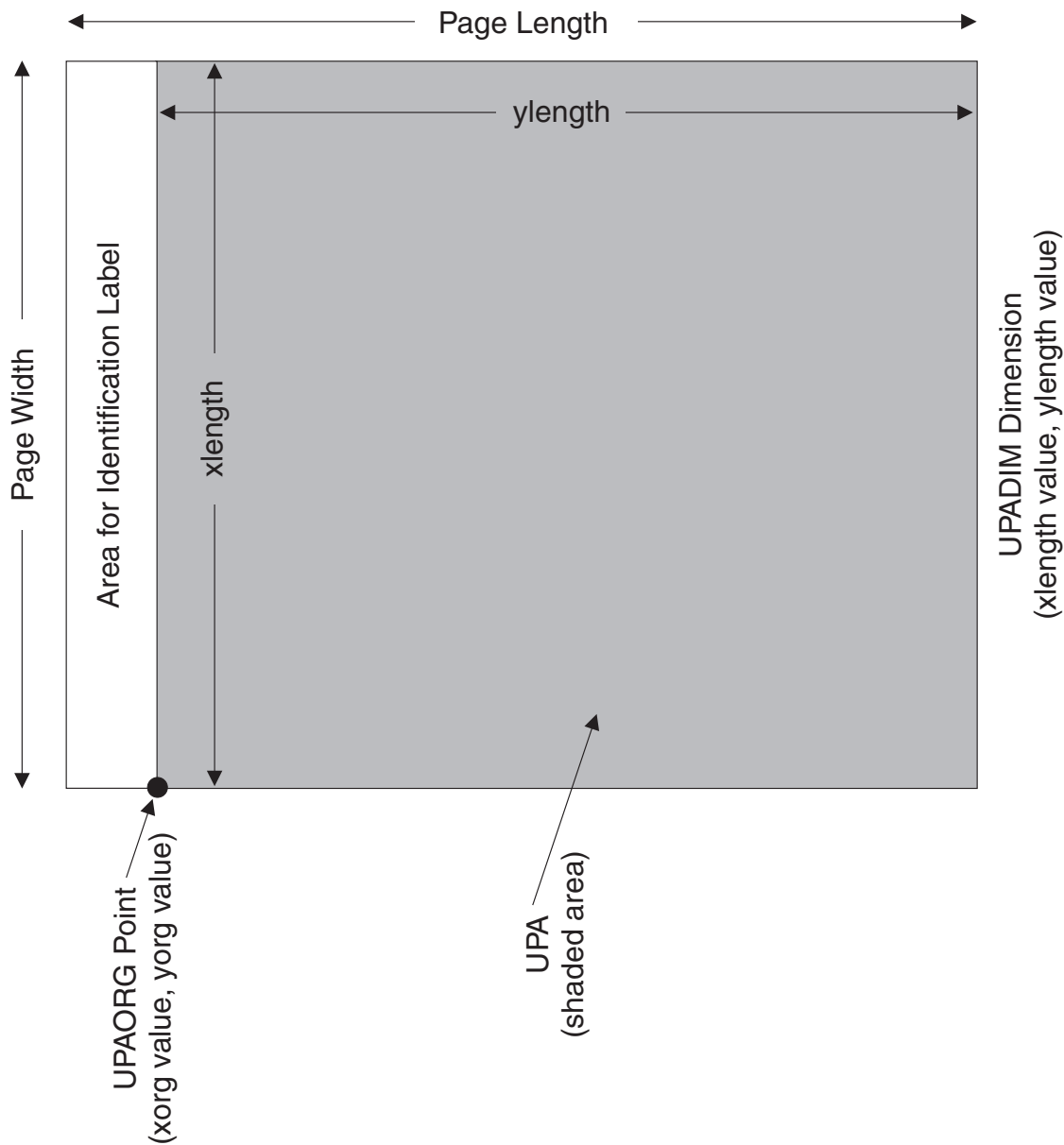


Figure 19. Security Page Layout. This template is for a page defined as TOP=NARROW.

## Glossary

This glossary defines technical terms and abbreviations used in PSF for z/OS documentation. If you do not find the term you are looking for, view the IBM terminology website:

These cross-references are used in this glossary:

- **See.** Refers to preferred synonyms or to defined terms for acronyms and abbreviations.
- **See also.** Refers to related terms that have similar, but not synonymous, meanings, or to contrasted terms that have opposite or substantively different meanings.

### A

**access control.** The process of ensuring that users can access only those resources of a computer system for which they are authorized.

### C

**concatenated data set.** A group of logically connected data sets that are treated as one data set for the duration of a job step. See also data set, partitioned data set, and library.

**console.** A display station from which an operator can control and observe the system operation.

### D

**data set.** The major unit of data storage and retrieval, consisting of a collection of data in one of several prescribed arrangements and described by control information to which the system has access. See also file, concatenated data set, partitioned data set, and sequential data set.

**data set header.** A page in printed output that separates multiple data sets or multiple copies of a data set within a print job. See also job header.

### F

**file.** (1) A collection of related data that is stored and retrieved by an assigned name. A file can include information that starts a program (program-file object), contains text or graphics (data-file object), or processes a series of commands (batch file). (2) See also data set, partitioned data set, sequential data set, and library.

**font.** (1) A family or assortment of characters of a given size and style, for example, 9-point Bodoni modern. A font has a unique name and might have a registry number. (2) A particular type style (for example, Bodoni or Times Roman) that contains definitions of character sets, marker sets, and pattern sets.

**form definition.** An AFP resource object used by PSF that defines the characteristics of the form or printed media, including: overlays to be used, duplex printing, text suppression, the position of composed-text data on the form, and the number and modifications of a page.

**FSA.** See functional subsystem application.

**FSS.** See functional subsystem.

**functional subsystem (FSS).** An extension of JES that runs in an address space separate from the JES address space. An FSS provides support for an auxiliary function to JES processing, such as a peripheral device or other component.

**functional subsystem application (FSA).** (1) An area within the functional subsystem (FSS) that drives and manages a single printer. FSAs are identified with JES printer definitions. (2) An application that uses the support facilities of the functional subsystem (FSS) to communicate with JES.

### G

**guaranteed print labeling.** A method of print labeling that ensures the integrity of the identification label by preventing the user from changing the label. If attempts are made to override print labeling, printing is stopped, and an audit record is written. See also nonguaranteed print labeling and identification label.

### I

**identification label.** In PSF, a protected set of resources (fonts, overlays, and page segments) that are used to label PSF output for security purposes. See also security label.

**Infoprint Server.** An element of z/OS that supports printing on local printers and remote printers in an Internet Protocol or SNA network. With Infoprint Server, users can submit print requests from remote workstations in an Internet Protocol network, from z/OS UNIX System Services applications, from batch applications, from VTAM® applications (such as CICS® or IMS), and from SAP R/3.

## J

**JCL.** See job control language.

**JES.** See Job Entry Subsystem.

**JES2.** An MVS™ subsystem that receives jobs into the system, converts them to internal format, selects them for processing, processes their output, and purges them from the system. In an installation with more than one processor, each JES2 processor independently controls its job input, scheduling, and output processing. See also Job Entry Subsystem and JES3.

**JES3.** An MVS subsystem that receives jobs into the system, converts them to internal format, selects them for processing, processes their output, and purges them from the system. In complexes that have several loosely coupled processing units, the JES3 program manages processors so that the global processor exercises centralized control over the local processors and distributes jobs to them by using a common job queue. See also Job Entry Subsystem and JES2.

**job.** A separately executable unit of work.

**job control language (JCL).** A command language that identifies a job to an operating system and describes the job's requirements.

**Job Entry Subsystem (JES).** An IBM licensed program that receives jobs into the system and processes all output data that is produced by jobs. See also JES2 and JES3.

**job header.** A page in printed output that indicates the beginning of a user job. A user job can contain one or more data sets, or one or more copies of a print job. See also data set header.

**job separation.** The ability to identify job boundaries by placing marks or sheets of paper between successive jobs.

**job trailer.** A page in the printed output that indicates the end of a user job.

## L

**library.** (1) A system object that serves as a directory to other objects. A library groups related objects, and allows the user to find objects by name. (2) A data file that contains copies of a number of individual files and control information that allows them to be accessed individually. (3) A partitioned data set or a series of concatenated partitioned data sets.

**licensed program.** A separately priced program and its associated materials that bear a copyright and are offered to customers under the terms and conditions of a licensing agreement.

## M

**media origin.** The reference point from which the logical page origin is positioned by the medium map. This point is represented by  $X_m=0$ ,  $Y_m=0$  in the  $X_m$ ,  $Y_m$  coordinate system. The media origin is defined relative to the upper-left corner of the form. See also logical page origin. See also .

**Multiple Virtual Storage (MVS).** An IBM operating system that accesses multiple address spaces in virtual storage.

## N

**nonguaranteed print labeling.** Some printers that do not support guaranteed print labeling can still print identification labels, but the integrity of the labels cannot be guaranteed by using PSF. See also guaranteed print labeling.

## O

**OGL.** See Overlay Generation Language.

**operating system (OS).** A collection of system programs that control the overall operation of a computer system.

**OS.** See operating system.

**overlay.** (1) A resource object that contains predefined presentation data, such as text, image, graphics, and bar code data, that can be merged with variable data on a page or form while printing. (2) The final representation of a collection of predefined presentation data on a physical medium.

**Overlay Generation Language (OGL).** An IBM licensed program used for designing objects (such as lines, boxes, shadings, and irregular shapes) for electronic overlays.

## P

**page definition.** An AFP resource object used by PSF that defines the rules for transforming line data and XML data into MO:DCA data and text controls, such as width of margins and text orientation.

**Page Printer Formatting Aid (PPFA).** An IBM licensed program with which to create and store form definitions and page definitions, which are resource objects used for print-job management. These stored objects are used to format printed output.

**page segment.** An AFP resource object containing text, image, graphics, or bar code data that can be positioned on any addressable point on a page or an electronic overlay.



**parameter.** A value or reference passed to a function, command, or program that serves as input or controls actions. The value is supplied by a user or by another program or process.

**partitioned data set (PDS).** A data set in direct-access storage that is divided into partitions, called members, each of which can contain a program, part of a program, or data. See also sequential data set.

**PDS.** See partitioned data set.

**physical page.** A single surface (front or back) of a form.

**PPFA.** See Page Printer Formatting Aid.

| **Printer Control Language (PCL).** The Hewlett Packard  
| page description language that is used in laser and  
| ink-jet printers.

**Printer Inventory.** In Infoprint Server, a set of files that contain information about printers. The Printer Inventory includes such objects as printer definitions, functional subsystem (FSS) definitions, and job selection rules for IP PrintWay.

**print job.** One or more documents submitted in the same job to be printed on the same printer.

**print labeling.** A controlled method of placing identification labels on each page of PSF printed output.

**Print Services Facility (PSF).** An IBM licensed program that manages and controls the input data stream and output data stream required by supported page printers.

**processor.** In a computer, the part that interprets and processes instructions. Two typical components of a processor are a control unit and an arithmetic logic unit.

**PSF.** See Print Services Facility.

## R

**RACF.** See Resource Access Control Facility.

**record.** (1) In programming languages, an aggregate that consists of data objects, possibly with different attributes, that typically have identifiers attached to them. In some programming languages, records are called structures. (2) A group of related data, words, or fields treated as a unit, such as one name, address, and telephone number.

**resource.** A collection of printing instructions used, in addition to the print data set, to produce the printed output. Resources include coded fonts, font character sets, code pages, page segments, overlays, form definitions, and page definitions.

**Resource Access Control Facility (RACF).** An IBM licensed program that provides for access control by identifying users to the system, verifying users of the system, authorizing access to protected resources, logging unauthorized attempts to enter the system, and logging accesses to protected resources.

## S

**security definition.** A member containing the definitions for one identification label. These definitions include instructions for the overlay name, and the size and origin of paper to be used.

**security definitions library.** A partitioned data set or a series of concatenated partitioned data sets that contain the security definitions for an entire system.

**security label.** In a trusted computing base, a label used to maintain multiple levels of security on a system. This label is a combination of a security class and a security level. See also identification label.

**security overlay.** An overlay, such as one created by use of Overlay Generation Language, that resides in a secure library and is used to place security resources on a page.

**separator page.** An identifying sheet of paper between successive jobs. See also job header and job trailer.

**sequential data set.** A data set whose records are organized on the basis of their successive physical positions, such as on magnetic tape. See also partitioned data set.

**SMF.** See System Management Facilities.

**SMF type 6 record.** A record that PSF uses to record data for each print data set.

**spool.** The system function of putting files or jobs into disk storage for later processing or printing. An abbreviation for "simultaneous peripheral operations online."

| **spool file.** (1) A file containing output that has been  
| saved for later processing. (2) A file that is used in the  
| transmission of data among devices.

**spooling.** The sending of data to auxiliary storage for later processing. The most common spooling application is print spooling.

**statement.** (1) In programming languages, a language construct that represents a step in a sequence of actions or a set of declarations. (2) An instruction in a program or procedure.

**System Management Facilities (SMF).** A component of z/OS that collects and records a variety of system

and job-related information. Examples of information collected by SMF are statistics, accounting information, and performance data.

## T

**terminal.** In data communication, a device, typically equipped with a keyboard and display device, capable of sending and receiving information.

**trusted computing base.** The part of the system that contains all the elements that support the security policy of the system. The trusted computing base includes all hardware, microcode, and software that protect information on the system.

## U

**UPA.** See user printable area.

**user ID.** See user identifier.

**user identifier.** A string of characters that uniquely identifies a user to a system.

**user printable area (UPA).** The area within the valid printable area (VPA) where user-generated data can print without causing an exception condition. See also valid printable area.

## V

**valid printable area (VPA).** The intersection of the current logical page or current overlay with the physical page in which printing is allowed. See also user printable area.

**VPA.** See valid printable area.

## X

**Xm, Ym coordinate system.** The media coordinate system.

## Z

**z/OS.** An IBM mainframe operating system that uses 64-bit real storage.
